

UCE EXECUTIVE AFFILIATE TERMS AND CONDITIONS CONTRACT

BY SIGNING UP AND BEING ACCEPTED AS AN EXECUTIVE AFFILIATE FOR UCE, YOU AGREE TO THE FOLLOWING TERMS AND CONDITIONS.

- 1. Executive affiliates will be chosen by the U.C.E team and advised of their confirmed status as an Executive Affiliate by email. The Executive Affiliate, if they have not done already, can then register as an Affiliate on the U.C.E website www.uceducation.online
- 2. The role of the Executive Affiliate is to refer potential students to any of the Doctorate course series on U.C.E www.uceducation.online
- 3. The Executive Affiliate will be given training on the Doctorate course series for promoting to potential students by the team at U.C.E.
- 4. Executive Affiliates may promote the courses in the following ways:
- * Local Promotions: Holding local talks or meetings,
- * Online Promotions: Using Social Media & Webinar promotions. This is not a full comprehensive list. Any outgoings or marketing costs are the full responsibility of the Executive Affiliate.
- 5. Any potential student that comes directly to the University of Consciousness Education may be referred to an Executive Affiliate. The Executive Affiliate nominated is at the sole discretion of UCE and chosen for any reason, such as location or expertise knowledge on a Doctorate course series. Each Executive Affiliate will be assigned a local area for this purpose.
- 6. Each Executive Affiliate will be listed on the U.C.E Executive Affiliate members directory for potential students to contact in their area.
- 7. Each Executive Affiliate once registered on the U.C.E website (www.uceducation.online) will need to generate a specific URL for their own affiliate link, to give the potential student the specific Doctorate course payment page. This URL will be kept by the student's same website browser for 60 days, so if the student signs up after the 60 days has elapsed or uses a different web browser, another specific affiliate URL must be generated for purchase and given to the student. The Executive Affiliate will only be paid if the student has used this specific URL within the 60-day period on the same website browser.

8. Referral Fee. The Executive Affiliate will receive a **15% commission on the first course sold to a new student of UCE**, if the above conditions are met. An exception to this is if the student opts for a **12-month payment plan on the doctorate course, in which case a 10% referral fee will be paid**. Referral Fees shall be paid as a **one-time fee for each referred student,** while the Referring Agent is in good standing and active UCE. There will be no other referral fees paid if a student then goes on to do further UCE courses. Referral Fees are based on paid course student enrolments with monies actually collected and received by UCE from the referred student.

Payment will be made via Transferwise to the Executive Affiliates nominated bank account as follows:

- * 15% payment will be made 30 days after U.C.E receives the first payment for a lifestyle course enrollment.
- * 15% payment will be made 30 days after U.C.E receives the first payment for a Doctorate Course enrollment, if they opt for the 1 full payment or the 3-month payment plan.
- * 10% payment will be made 90 days after U.C.E receives the first payment for a Doctorate Course enrollment if they choose the 12-month payment plan option, as long as the 2 subsequent monthly payments go through.

If any of those payments default and are not paid, the Executive Affiliate forfeits their commission payment and will not be paid by U.C.E.

No Referral Fees shall be due on outstanding or unpaid customer invoices.

- 9. Company Discretion. UCE has the right to determine whether it will accept an enrolment of a prospective student.
- 11. Relationship Between UCE and Executive Affiliates. The Executive Affiliate shall operate as an independent contractor and shall not act as, or be, an agent, employee, partner or joint venturer of UCE. The Executive Affiliate shall in no way have authority to bind or obligate UCE in any respect.
- 13. Termination. UCE reserves the right to terminate the Executive Affiliate status
- * if they are not actively making referrals to gain doctorate course sign ups. This is at the discretion of UCE.
- * for breaches of confidentiality or intentional misrepresentations or fraudulent actions
- * If the Executive Affiliate does not produce a monthly enrolment in our preferred Doctorate series or focuses only on the Lifestyle courses, then U.C.E reserve the right to review the Executive's progress and the 15% Affiliate fee.
